

Future Film Pitch

- **Title:** The Murder of Prince's ex-wife
- **Genre:** Action
- **World:** The royal family is at risk. Their only son, Asher, is at risk because of a crime he did not commit.
- **Protagonist:** the head of the police department (Martha Lewis)
- **Antagonist:** Countess Bathory (the prince's second wife)
- **Somebody wants something badly and is having difficulty getting it:** The Prince is trying to figure out who killed his ex-wife and why.
- **Inciting Incident:** The Prince's ex-wife gets killed at his wedding to his second wife.
- **Act one**

Asher is living a life that millions of people dream of. His father and mother are very old, and he is the only son. The royal family will disappear if anything wrong happens to their son because there is no one else to inherit them except a two-year-old dog. Asher decides to get married to a second wife and divorce his first one because the law allows marrying only one wife. (Plot point 1) He chooses to marry a second wife because the family doctor tells him his wife has infertility and cannot get pregnant. He loves her so much and does not want to divorce her. He talks to his parents for months, trying to convince them he cannot divorce his wife. His parents lost their patience because they understand if he does not get married, their family wealth would go to the dog. His mother's health gets so bad because Asher does not agree to divorce and get married to another woman, and his mother dies because of that. Then Asher decided to get a divorce.

- **Act two**

After two months of Asher's divorce, his family found him a woman for another royal family; her name is Countess Bathory. After two months of dating, they decided to get married. Bathory is five years older than Asher, and her biological mother is in charge of the police department of the whole country. Bathory only cares about money and not about people, but she is good at acting that she cares about people. Today is Asher and Bathory's wedding. Bathory plans to kill the prince's ex-wife because she does not want her to get some of the wealth by filing a lawsuit against Asher. Bathory sends an invitation letter to Prince's ex-wife to invite her to the wedding. She put the prince's name on the letter and write, "I will not marry Bathory, and I will announce that in the wedding hall. Please come to see that" she writes the same handwriting as Prince's. She tricks Prince's ex-wife and makes her come to the wedding. Then hire someone to kill her there and then say the one who killed her is the prince so she can inherit him because the law of the land is if a person intentionally kills another person, he/she will be killed as a punishment. The prince's wife gets killed in the wedding hall (Plot point 2). Then the police of the head department is investigating this crime.

- **Act three**

Asher is taken to jail because he has been accused of killing his wife. After all, the police department thought Prince killed his ex-wife because she would file a lawsuit against him and take some of his wealth. Martha Lewis did not believe that story. She kept investigating the matter for one year. One day she goes to Prince's ex-wife's house and finds the letter sent to the prince's wife. She notices something strange. All the writing looks like Prince's handwriting, except the letter p is very similar to her daughter's handwriting (Bathory), not The Prince's. Then Martha Lewis starts a new investigation. Bathory finally admits her crime, and Martha Lewis takes her to

jail and tells her, "I know you are my daughter, but the law is above you and me." Then Price is free from prison, and after a year, he gets married. Martha Lewis tells The Prince that the reason her daughter killed his ex-wife is that she is greedy, and she wants all his family's money. The prince says, "I have depression because I could not find the answer to why and who killed my ex-wife, but I feel relief now, thank you."
